Sir,

In supersession of this office sanction letter of even number dated 30th March, 2011 on the subject cited above, I am directed to inform you that on the basis of recommendation of the Expert Committee, the University Grants Commission has approved your proposal and is agreed to provide the financial assistance of Rs.2,50,000/- (Rupees two lakh fifty thousand only) for approved introduction of Foundation Course (2-3 months).

I am also directed to convey the sanction of the Commission for payment of Rs.2,35,000/- (Rupees two lakh thirty five thousand only) to the E.M.E.A. College of Arts and Science, Kondotty, Dist. Malapuram Kerala - 673 638 for introduction of Foundation Course (2-3 months) under the Plan expenditure as per detail given below:-

- The sanctioned amount is debit to the major Head ~~5(iv)(31)~~ and is valid for payment during the financial year 2011-12 only.
- The amount of the Grant shall be drawn by the Under Secretary (Drawing and Disbursing Officer) U.G.C. on the Grants-in-aid bill and shall be disbursed to and credited to The Principal, E.M.E.A. College of Arts and Science, Kondotty, Dist. Malapuram, Kerala - 673 638 through Cheque/Demand Draft/Mail Transfer.
- The Grant is subject to the adjustment on basis of Utilization Certificate in the prescribed Proforma submitted by the College.
- The College shall maintain proper accounts of the expenditure out of the grants, which shall be utilized only on approved items of expenditure.
- The Utilization Certificate to the effect that the Grant has been utilized for the purpose for which it has been sanctioned shall be furnished to the University Grants Commission as early as possible.

7. The assets acquired wholly or substantially out of University Grants Commission's Grants shall not be disposed or encumbered or utilized for the purposes other than those for which the grant was given, without proper approval of the University Grants Commission and should, at any time the College ceased to function, such assets shall revert to the University Grants Commission.
8. A Register of Assets acquired wholly or substantially, out of the grant, shall be maintained by the College in the prescribed form.
9. The grantee institution shall ensure the utilization of grant-in-aid for which it is being sanctioned / paid. In case non-utilization/part utilization, a simple interest @ 10% per annum as amended from time to time on unutilized amount from the date of drawal to the date of refund as per provisions contained in General Financial Rules of Govt. of India will be charged.
10. The interest earned by the College on this grants in aid shall be treated as additional grant and may be shown in the Utilization Certificate/Statement of expenditure to be furnished by grantee institution.
11. The College shall follow strictly all the instructions issued by the Government of India from time to time with regard to reservation of posts for SC/ST/OBC/PH etc.
12. The College shall fully implement the Official Language Policy of Union Government and comply with the Official Language Act, 1963 and Official Language (use for official purposes of the Union) Rules, 1978 etc.
13. The Sanction issues in exercise of the delegation of powers vide Commission office order No. 25/92 dated May 01, 1992.
14. Ist Installment.
15. It is certified that the funds are available under the scheme is entered in B.C.R. at S. No.188 Page No.63. The above grant is sanctioned against the revised budget provision of Rs.2,00,00,000/- during the current financial year under the Head of 5(iv)(31).
16. The Funds to the extent are available under the Scheme.
17. The College shall include a specific condition in the Utilization Certificate in respect of any financial assistance of grants-in-aid to any institution under any of the general or special scheme of the Commission that the College has complied with the anti-ragging measures by stating that:

"The College is strictly following the UGC Regulations on curbing the menace of Ragging in Higher Educational Institutions, 2009".
