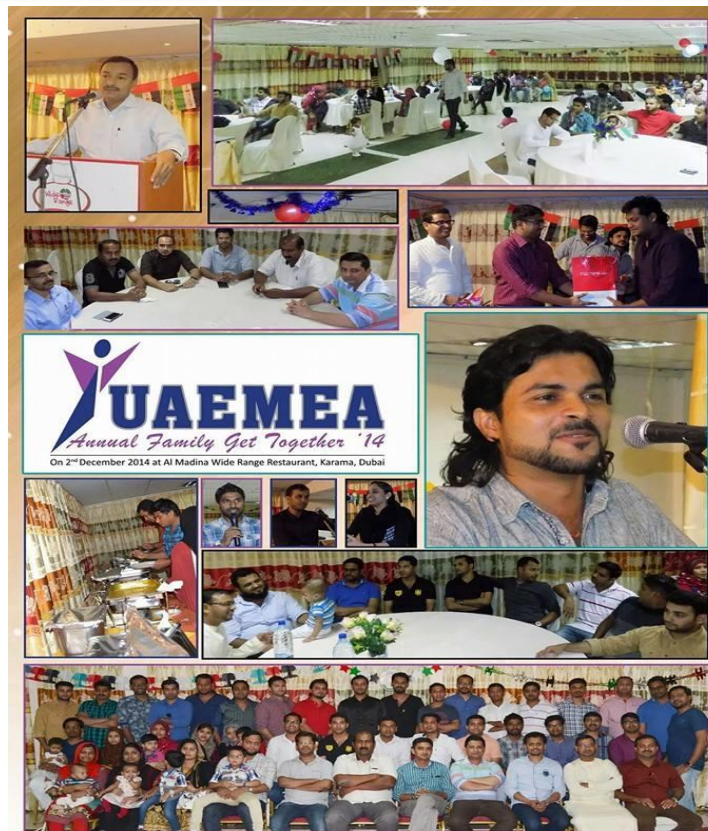


ALUMNI MEETS

1. UAE CHAPTER ANNUAL MEET

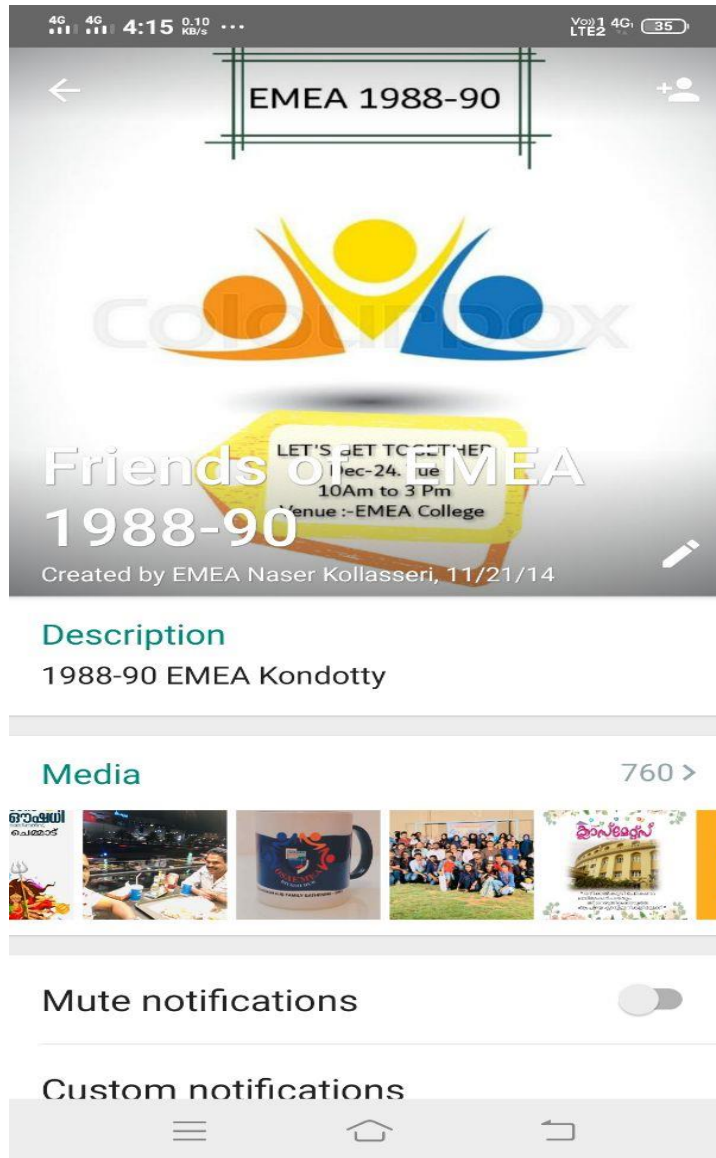

Maddeena Wide Range Restaurant, Karama(Dubai). Around 40 old students from different parts of UAE and family members attended the meeting.



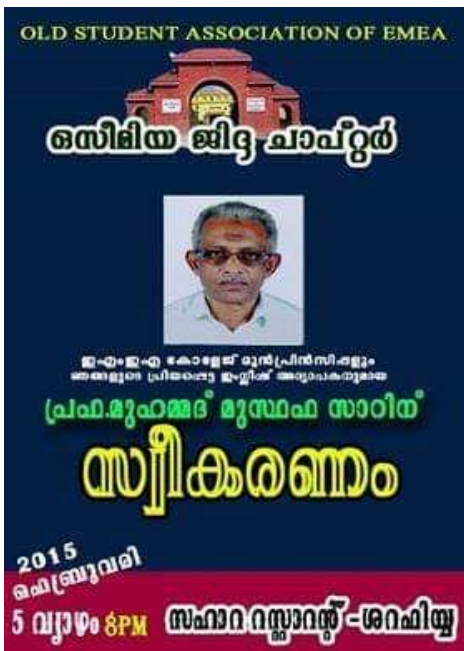
2. Friends of EMEA Meet (1988-90 Batch meet)

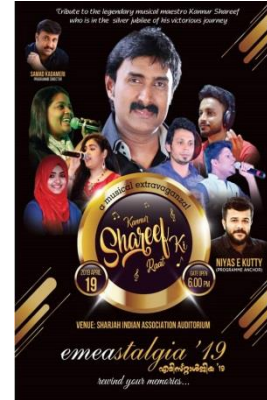

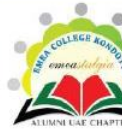

- D) To collect funds by subscriptions, contributions, donations and gifts from members, non-members, Governments, Universities and other institutions and philanthropists for furtherance of the above objectives.
- m) To further such objects as the General Body may decide from time to time. ASSOCIATION shall be governed by these bye-laws and any rules that may be framed/amended in future, in harmony therewith, as may be adopted as herein provided.

10. MEMBERSHIP

The Association shall have the following categories of members fulfilling the eligibility criteria specified below:

All Pre-Degree, Degree, PG, M.Phil and Ph.D. graduates of EMEA College (henceforth referred as OSAEMEANS) who have completed at least one full academic year in the campus as student and acknowledged the very ethos of OSAEMEA's vision and mission are eligible to be members of the Association. Membership is open to all persons irrespective of caste, creed, race, sex or religion. Alumnus can either enroll as an ordinary member or as a life member. Alumnus studied in the college as a regular student has to submit the application in the prescribed format either through the web or in print form by paying the membership fee of Rs. 200/2000 shall be admitted as an ordinary/life member having voting rights. The membership and subscription fees are subject to revision from time to time with the approval of the General Body.

6.1. Ordinary Member

Alumni who enroll as an ordinary member on payment of an annual membership fee of Rs.200 have voting rights for that year only. An ordinary member shall renew his/her membership every year and if he/she does not do so he /she ceases to be a member.

6.2. Life member:

Alumnus who subscribes to a life membership paying Rs 2000/ shall have voting rights for his life time.

6.3. Non-Resident Alumni Member:

An EMEA alumnus working away from his country and has subscribed either as an ordinary member or as a life member in any alumni chapter, become a member of the parent association by virtue of his membership in the overseas chapter or outside the state but shall not exercise voting rights in Old Students of EMEA. He can avail voting rights by subscribing any one of the memberships mentioned in the eligibility clause.

6.4. Honorary Member:

Academic and administrative staff of the college is entitled only to avail Honorary Membership. Former academic and administrative staff of the college may continue to remain honorary members of the Association on the payment of Rs.1000/- for life membership or Rs.100/- per annum as yearly membership to the Association. Eminent persons who have not completed at least one academic year in the college may also be admitted as honorary members at the approval of the Executive Committee of the Association. Such honorary members have no voting rights.

6.5. Cessation of Membership:

A member of the Association shall cease to be a member on the happening of any of the following events – If he/she dies, resigns, becomes unsound mind, becomes insolvent or be convicted of a criminal offence involving moral turpitude. A member who is convincingly found in defaming the institution, management and act against the vision and mission of the college shall be expelled from the primary membership of the association. A member who misappropriates the funds shall be disqualified from the membership of the association.

6.6. Enrollment

A register of members shall be kept at the registered office of the Association. If a member changes his postal and/or e-mail address, he shall notify his new address to the Alumni Association Office and the entry in the register shall be accordingly changed; but if he/she fails to notify his/her new address, the address in the roll of members shall be deemed to be his/her address.

All communication to the members will be through Postal, e-mail or SMS unless specifically requested by the member in writing.

A resignation from membership shall be tendered to the President and it shall not take effect until it has been accepted on behalf of the Association by the Executive Committee.


II. EXECUTIVE COMMITTEE

There shall be an Executive Committee to manage affairs of the Association. The Association shall function through its Executive Committee (hereafter referred to as EC) which shall comprise of the following Elected, Nominated and Ex-Officio members:


7.1. Election to the Executive Committee

I. **Elected Members** :(having voting rights):- The General Body shall elect all the **Executive Committee members** through elections, which shall be conducted as per the procedure laid down in the Bye-laws of the Association. The General Body shall elect 7 to 40 members for the Executive Committee at the Annual General Body Meeting (AGBM). Members of the Executive Committee will be elected for a period of TWO years.



- II. **Nominated Members:** Besides the elected members the executive committee at its first meeting may nominate not more than five ordinary / life members and their term shall be co-terminus with that of the incumbent EC.
- III. **Chief Patron:** College manager/Correspondent
- IV. **Patron of the association:** Principal shall be the ex-officio Patron of the Association
- V. **Ex-Officio members: (having voting rights)**
- Principal, ex-officio Patron
 - Immediate past President of the Association
 - Immediate past General Secretary of the Association

12. GENERAL BODY

There shall be general body of the Association consisting of all members. The Regular and Life Members shall comprise the General Body of the Association.

13. QUORUM AND VOTES

The quorum for a General Body Meeting shall be 50 and for the executive committee seven members.

Every member shall have one vote and in case of equality of votes, the Chairman of the meeting shall have a casting vote. A member shall not vote by proxy

14. POWERS AND DUTIES

a. Executive Committee

- The affairs of the Association shall be managed by an Executive Committee consisting of a Patron, President, two Vice-Presidents, a General Secretary, three Secretaries, a Treasurer, and thirteen elected members.
- In addition to the above, the Executive Committee may co-opt additional members for any specific purpose, as deemed necessary. The co-opted members have to step down at the next Annual General Body meeting. The co-opted members and ex-officio members will not have voting rights.
- The quorum for an Executive Committee meeting shall be 7 elected members.
- The Executive Committee shall have the power to incur expenditure necessary to carry out the aims of the association.
- Vacancy in the Executive Committee arising on account of resignation, or otherwise, of the same may be filled up by the Executive Committee by co-option.
- The Executive Committee shall have the power to frame/amend bye-laws consistent with the aims and objects of the Association. Such provisional bye-laws shall be placed before the next General Body Meeting for ratification.

Term of office of executive committee:

The term of the EC shall be two years from the date of assuming office and shall be reconstituted every alternate year.

Any Executive committee member who is absent for six consecutive Executive Committee meetings without a formal leave request shall automatically ceases to be a member of the Executive Committee

b. General Body

The General Body shall be the supreme body of the Association in taking decision on any matter relating to the Association and on all matters brought before them by the executive committee of association or by any member of the Association. The General Body shall function in accordance with Bye-Laws of the Association.

The Annual General Body Meeting of the Association shall be held in the month of **December** every year, at the college premises or at such notified place and at such time and date as the Executive Committee may determine to transact the following business:

- 1) To approve the annual report and the audited statement of accounts of the Association for the previous financial year ending 31st March.
- 2) To elect the members of the Executive Committee of the Association
- 3) To discuss, and resolve matters of general interest to the members which may be placed before the meeting or any other matter for which seven days' notice has been received from any member, subject to the permission of the Chair.
- 4) At least 21 days' notice shall be given for holding the Annual General Meeting.
- 5) The General Body of the Association shall hold the annual general body meeting at least once a year and not more than 18 months shall elapse between two successive Annual General Body meetings.
- 6) An extraordinary General Body Meeting of the members of the association may be called by the Executive Committee. Such Extraordinary General Meeting may also be called at the request made to the Executive Committee in writing by at least one fourth of the members of the Association. The meeting shall be called within one month from the date of receipt of their requisition in writing. For holding an Extraordinary General Body Meeting, 21 days clear notice shall be given to the members specifying the business to be transacted.
- 7) An emergent meeting of the General Body can only be convened by the President for compelling reasons at a short notice.
- 8) Simple majority consists of hundred (100) members shall form the quorum for any meeting of the General Body. If the meeting is adjourned for want of quorum, the adjourned meeting will be convened on the same day after one hour to transact the same business and members present shall form the quorum.

He shall direct the General Secretary to convene meetings and shall preside over the meetings of the EC as well as the General Body and shall maintain or cause to maintain their minutes. In Subject to any subsisting interpretation given by the EC, the President shall have authority to interpret the Constitution and the Bye-Laws of the Association for the purpose of conducting the meeting and deciding the questions arising at such meeting.

Vice President

The EC or the President may assign any responsibility to Vice Presidents. In the absence of President, the senior Vice President shall preside over meetings of the General Body and the EC and exercise all powers of the President.


General Secretary

- a) The General Secretary shall look after the affairs of the Association under the supervision of the President.
- b) General Secretary shall be head of the Registered Office and Head Office of the Association. He shall maintain and keep or cause to be maintained and kept all records of the Association, including register of members, elections, minutes and agenda and all other records of the meetings of the General Body, executive committees and sub-committees constituted by General Body, or President.
- c) He shall act as liaison between the Association and the college on one hand and the Association and the college's student body on the other. He shall also represent the Association in various bodies and meetings of the college.
- d) He shall do everything necessary to give effect to the resolutions passed and decisions taken by the General Body and executive committee. He shall keep the President and the executive committee apprised of the progress made in this respect from time to time.
- e) Jointly with president, sign all cheques.
- f) He shall also file all returns under the Societies registration Act, 1860 and rules made there-under and any other law mandating filing of returns.

Treasurer

- a) The Treasurer shall advise the EC on financial matters, supervise all financial transactions and cause to maintain and supervise account records of the Association.
- b) He shall exercise and monitor all financial transaction; Receipts and Expenditure of the Association,



- c) Collection of grants and donations received by the Association,
 - d) Compilation of Statements of Accounts,
 - e) Audit of accounts and making all records available for the scrutiny, to the auditor,
 - f) Presenting Annual Accounts and Audit Report before the Board and in the Annual General Body (AGBM),
 - g) Ensure that all accounts books are maintained properly and are up to date,
 - h) Make investment by way of fixed deposits and security in banks in consultation with President and General Secretary,
 - i) Filing in consultation with General Secretary, returns under the Income Tax Act, Foreign Exchange regulation Act and any other prevailing law,
 - j) Ensure that all the due payments are made to the Association and issue all necessary receipts, and
 - k) Keep the EC informed of the financial condition of the Association.

Secretary

- a) All elected secretaries shall discharge the duties assigned to them by EC from time to time.
- b) In the absence of the General Secretary the senior secretary shall take up the duties of the General Secretary.

Election of Office Bearers from the executive committee

General

- a) All the elected posts of the new Executive Committee shall be filled by elections in the General Body every alternate year. Election shall be conducted either by submission of panels or by ballot.
- b) Every member of General Body shall be eligible to be elected as President, Vice President, General Secretary, Secretary and Treasurer and elected members of the Executive Committee, subject to the conditions specified in the Constitution.
- c) Every member of the Executive committee shall have one vote for each post. Vote by proxy is in no case permitted.
- d) Every member of the Executive committee shall have the right to cast only one vote for each post, and to propose and second only one candidate for each of the elected positions of the Executive Committee.
- e) Election Officer - On behalf of the General Body/Executive committee, elections shall be conducted by an Election Officer, appointed by the outgoing Executive Committee at least 30 days in advance. The Election Officer shall be the Patron or his nominee not below the rank of an Associate Professor.

- f) Conduct of Elections. The Election Officer shall be responsible for receipt of nominations, acceptance of withdrawals, scrutiny of nominations, hearing of objections against nominations, actual conducting of elections and announcement of election results in the meeting of General Body/Executive committee.
- g) Nominations: Every nomination shall be required to be duly proposed by at least one member of the General Body and seconded by any member of the General Body other than the proposers. Each nomination shall have the consent of the nominee.
- h) No member shall nominate more than one candidate for the same post. No member shall second more than one candidate for the same post. No member, who nominates a candidate for a post, shall second another candidate for the same post. No member, who seconds a candidate, shall nominate another candidate for the same post. In case of any violation, the first entry shall be considered valid.
- Immediately after the elections election officer shall publish the final list of elected candidates.

15. FUNDS AND ITS MANAGEMENT

a. Source and Funds

Funds may be collected by subscriptions, contributions, donations and gifts from members, non-members, Governments, Universities and other institutions and philanthropists.

b. Disbursement of Funds

1. To provide assistance to alumni and their families where deemed fit by the association.
2. To render assistance to students of the college through grants, scholarships and prizes and to provide assistance in academics, placement or any other area that is felt as appropriate by the association and the college
3. To contribute towards improvements in the status of the college in areas pertaining to academics, infrastructure, industry interactions and any other area that the alumni and the college feel appropriate.
4. To facilitate improvement in networking among alumni.
5. To provide a platform for social interactions and enable higher levels of interactions.

To enable interactions between alumni for mutual benefit in academic, employment/or business areas.

c. Management of Funds

1. All investments of the funds of the Association, including receipts of deposit and all deeds and documents relating to any of the properties of the Association, shall be kept for safe custody with the Patron(Principal) as approved by the Executive Committee
2. Subject to the conditions, the Patron(Principal), President, General Secretary and Treasurer shall deal with and dispose of all properties, whether movable or immovable, and the income thereof in accordance with the direction of the Executive Committee evidenced by a resolution and not otherwise.
3. Subject to the approval of the Executive Committee evidenced by a resolution thereof, all documents whether relating to any immovable or movable property, whether made over to the Association or belonging to the Association including Agreements, Conveyances, Mortgages, Deeds of gifts or leases shall be in the name of the Association and executed by the general Secretary or any other Office Bearer authorized by the Executive Committee.
4. The Office Bearers shall be respectively chargeable only for such properties, money, funds, securities, or any other property as they shall respectively receive notwithstanding their signing any receipt for the sake of conformity and shall be answerable and accountable only for their own acts and defaults and not for those of any other members or any other banker, broker, auctioneer, agent or person with whom or into whose hands the money or securities of the Association may be deposited, for the insufficiency or deficiency or any funds or securities and for any other loss under the same, except when it happens through their own dishonesty or willful default respectively.

None of Office Bearers and Members of the Executive Committee shall be entitled to stipend, salary or pay from the Association. However, they shall be entitled to reimburse themselves or pay and discharge out of the Funds of the Association expenses incurred and payment made by them in or about execution of the objectives of the Association or in relation thereto with the approval of the President

11.1. Audit of Account

Auditors shall present their report to the Executive Committee, who shall place the same with its report in the Annual General Body Meeting (AGBM) for the consideration and approval of the General Body in accordance with Bye-Law

11.2. Book of Account

The books of accounts of the Association shall be open to the inspection of a panel appointed by the Executive Committee of the Association if it deems necessary and it shall be the duty of the General Secretary to produce the same on request by the panel.

17. ANNUAL GENERAL BODY MEETING


The Annual General Body Meeting of the Association shall be held in the month of December every year, at the college premises or at such notified place and at such time and date as the Executive Committee may determine to transact the following business:

- a) To approve the annual report and the audited statement of accounts of the Association for the previous financial year ending 31st March.
- b) To elect the members of the Executive Committee of the Association
- c) To discuss, and resolve matters of general interest to the members which may be placed before the meeting or any other matter for which seven days' notice has been received from any member, subject to the permission of the Chair.
- d) At least 21 days' notice shall be given for holding the Annual General Meeting.
- e) The General Body of the Association shall hold the annual general body meeting at least once a year and not more than 18 months shall elapse between two successive Annual General Body meetings.
- f) An extraordinary General Body Meeting of the members of the association may be called by the Executive Committee. Such Extraordinary General Meeting may also be called at the request made to the Executive Committee in writing by at least one fourth of the members of the Association. The meeting shall be called within one month from the date of receipt of their requisition in writing. For holding an Extraordinary General Body Meeting, 21 days clear notice shall be given to the members specifying the business to be transacted.
- g) An emergent meeting of the General Body can only be convened by the President for compelling reasons at a short notice.
- h) Simple majority consists of hundred (50) members shall form the quorum for any meeting of the General Body. If the meeting is adjourned for want of quorum, the adjourned meeting will be convened on the same day after one hour to transact the same business and members present shall form the quorum



2. Each Chapter shall be assigned geographical boundaries by the executive committee of the parent alumni (Old Students Association of EMEA) for the purpose of its functioning and activities.
3. The regulation for composition, organization and management of the Chapters and for the observance by the members thereof shall, at all times, be in accordance with the Byelaws of Old Students Association of EMEA and the Rules and Regulations of the association as may be adopted from time to time.

16.2. Activities

- 5) Maintain close liaison between the Central Chapter and the Outer Chapters in the region.
- 6) Offer assistance and co-operation and liaise with Old Students Association of EMEA College
- 7) The scope and manner in which the activities of the Chapters are to be organized will be determined by the concerned chapters conforming to the ideals and objects fixed by the Old Students Association of EMEA.
- 8) In the event of any dispute, the decision of the Chief patron shall be final and binding.
- 9) For the purpose of forming a Chapter, minimum sustaining membership shall be ten.

16.3. Membership Chapters

1. Every member of the association shall be attached to the local Chapter where he normally resides.
2. A member requiring transfer from one Chapter to another Chapter on account of a change of place of his business or employment, or residence, shall have the option of transfer but no members shall belong to more than one Chapter at a time.
3. Members may receive notice of, and may attend meetings of all Chapters but shall have voting rights only in the Chapter to which he is attached

1. If any Chapter or the Parent Association is found to be going against the vision and mission of the college Ernad Muslim Educational Association, the chief patron in consultation with the College governing body shall exercise the right to dissolve such Chapter or Parent Association.





