REPORT ON THE WEBINAR ORGANISED BY DEPARTMENT OF BVoc ON THE TOPIC 'START UP MANAGEMENT'

Start ups are companies or ventures that are focused around a single product or service that the founders want to bring to market. These companies typically don't have a fully developed business model and, more crucially, lack adequate capital to move onto the next phase of business. Most of these companies are initially funded by their founders. Start up Management is a daily destination where entrepreneurs learn about managing, growing and scaling start ups, almost like an virtual open university. Its content is focused on management, strategy, organizational and marketing topics, including business models, revenue models and go-to-market approaches. Vocational courses are seen by both employers and employees as bridging the gap between the syllabus and requirements in the job market.
