Sub: report of clash between two group of students reg:-
Ref: your letter dated 08/02/2022

As per the directions in the reference cited above, the enquiry committee summoned the students involved in the untoward incident happened on 3/02/2022 between second year BBA student(Nihal EK, Fourth Sem BBA) and B.Com Students(Mohammed Danish CK VI sem B.Com Coop , Mohammed Shanif, I sem B. Com Coop, Nisam Raseel , I sem B. Com Coop and Mohammed Salih , I sem B. Com CA).

Mohammed Shanif and Nisam Raseel while walking through the passage between main block and Commerce block around 3. 45 PM Thursday, they asked something about the things he carries, then Nihal EK in return used some unparliamentary words to Nisam and Shanif. Then around 4 PM Mohameed Dansih questioned Nihal EK about the incident in front of the BBA Department. During this Mohammed Danish terrorized and threatened Nihal EK.

After detailed enquiry the committee came to the conclusion that both Nihal EK and Mohammed Danish are the trouble makers and they tried to disturb the discipline in the campus. The committee also noticed that the other students are not that much involved in the incident as accused by Nihal EK.

In the above circumstances, the committee unanimously recommends that Mr. Nihal EK and Mohammed Danish need to be suspended at least for 15 working days from the campus in order to maintain discipline of the campus. The committee also recommends to summon the parents of the other accused and warn them not to involve in any indisciplinary activities further.
