SUMMARY REPORT

The Department of Microbiology offered an internship on "Water Quality and Wastewater Analysis" to MSc Microbiology students during the academic year 2023-2024. The primary goal of this internship was to provide students with a comprehensive understanding of laboratory skills through hands-on experience in water quality and wastewater analysis. A total of 20 students successfully completed the internship, which was conducted in collaboration with Ecosafe Enviro Tech Lab in Kozhikode.

Commencing on November 14, 2023, and concluding on November 17, 2023, the program consisted of 30 hours of instruction, covering both theoretical and practical sessions. Mr. Jaseel O C, Mr. Aadil, Ansi Mahamood, and Merin George conducted various theory sessions, while practical sessions were facilitated by Mr. Jaseel OC, an analyst from Ecosafe Enviro Tech Lab. The program concluded with a valedictory session, during which certificates were distributed to all participating students.

This internship has proven instrumental in enhancing students' prospects for employment in water quality laboratories, the drinking water industry, and wastewater

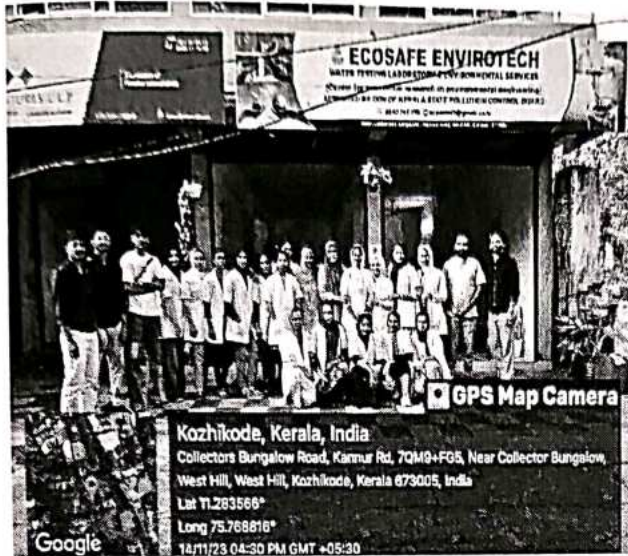

REPORT

On 21ST November 2023, the Department of History and West Asian Studies conducted one day heritage walk with 58 students of 1st semester BA West Asian Studies and 16 students of MA History PSMO College along with two faculty members of the EMEA College (Mr.K T Firos , Asst.Professor and Head of the Department & Ms. Haseena KV) and a faculty member from PSMO College (Ms.Saleena.M ,Asst.Professor and Head of the Department of History). They were visited different historical places of Kondotty ,such as Kondotty Takiya ,Kondotty Qubba, Pazhayangadi masjid, Moin Kutty Vaidyar Smarakam etc. The heritage walk began at 9.45 AM from EMEA College at Kondotty. K T Firos ,HoD led the walk explaining various facets of history that lie scattered throughout the areas of Kondotty.

Kondotty has rich history and a best place to go on a heritage walk. Kondotty is a developing town and municipality in the Malappuram district of Kerala. The Nediyrippu area of Kondotty city was the original home of the powerful dynasty of the Zamorins of Calicut (Eradi dynasty) who were actually the rulers of Eranad. The history of Kondotty is also connected with that of the 18th century Kondotty Thangals, the sufi exponent. Tipu Sultan of Mysur brought the first Thangal Muhammed Shah, to bring the Mappilas on his side. The Thangal first resided at Areekode and later settled in Kondotty. The Thangal family had a powerful influence in society and politics at that time. Kondotty is famous for Nercha in the Pazhayangadi mosque and also Kondotty is the birth place of famous Mappila poet Moinkutty Vaidyar.

At first, they visited the Kondotty Takiya. Takiya was the centre of spiritual activities, where Muhammad Shah engaged in meditation. He was the guide of Qadiri Twariqah. This centre still preserved well.

Kondotty Qubba is another important place ,they were visited. The history of Qubba is also related with the Kondotty Thangals. It is a Dargha where Sheikh Mohammed Shah thangal rest in peace. The construction of Qubba had started during the period of Aftab Sha and completed during the period of Ishtiaq Shah. Skilled craftsmen from Pune and Madurai along with the local craftsman were allotted to execute the Persian style of stone work. The famous Kondotty Nercha festival is celebrated here. During the time of Nercha ,all the villagers of Kondotty will come with their gifts to the Thangal Uppappa. The gifts are brought in a great procession to the house of the Thangal in Kondotty.

Pazhayangadi mosque, also known as Kondotty mosque is a centuries old pilgrim centre for Muslims. Located 18 kilometers east of Manjeri, this shrine is on the way to Malappuram .The mosque was built in memory of Muhammad Shah. This mosque was built in

white marble following the traditional Mughal Architecture and sculpture. This mosque has a white large dome that rises like a beacon among the rich hilly environment.

Moin Kutty Vaidyar Smarakam was another important cultural heritage centre of Kondotty. Moinkutty Vaidyar, often referred to as Mahakavi, is historically considered one of the most renowned poets of the Mappila pattu genre of Malayalam language. Moinkutty was born to Unni Mammad and Kunjamina, near Kondotty. Unni Mammad was a famous practitioner of Ayurvedic medicine and a poet too. Moinkutty continued this family tradition of Ayurvedic medical practice and learned Sanskrit and Arabic Languages. At a young age of seventeen, he composed the romantic epic *Bdarul Muneer-Husnul Jamal* (1872). It narrates a fictional love story between prince Badarul Muneer, the son of the king Mahazin of Ajmeer and Husnul Jamal, daughter of his minister Mazmir. Other important works of the poet include *Elippada, The story of Camel and Deer, Bethilappattu, Hijra, Moolapuranam, Uhad Padappattu, Swaleeqat h, Karamath mala* etc. The Moinkutty Vaidyar Smarakam is a memorial building dedicated to him at his birth place. It was a long cherished dream of Mappilappattu lovers all over Kerala. The Smarakam was built to promote traditional Mappila culture and arts. A Museum is located within the smarakam depicting the unique feature of Malabar culture and social life. There also existing an art gallery which showcasing various aspects of mappila culture, arts and literature.

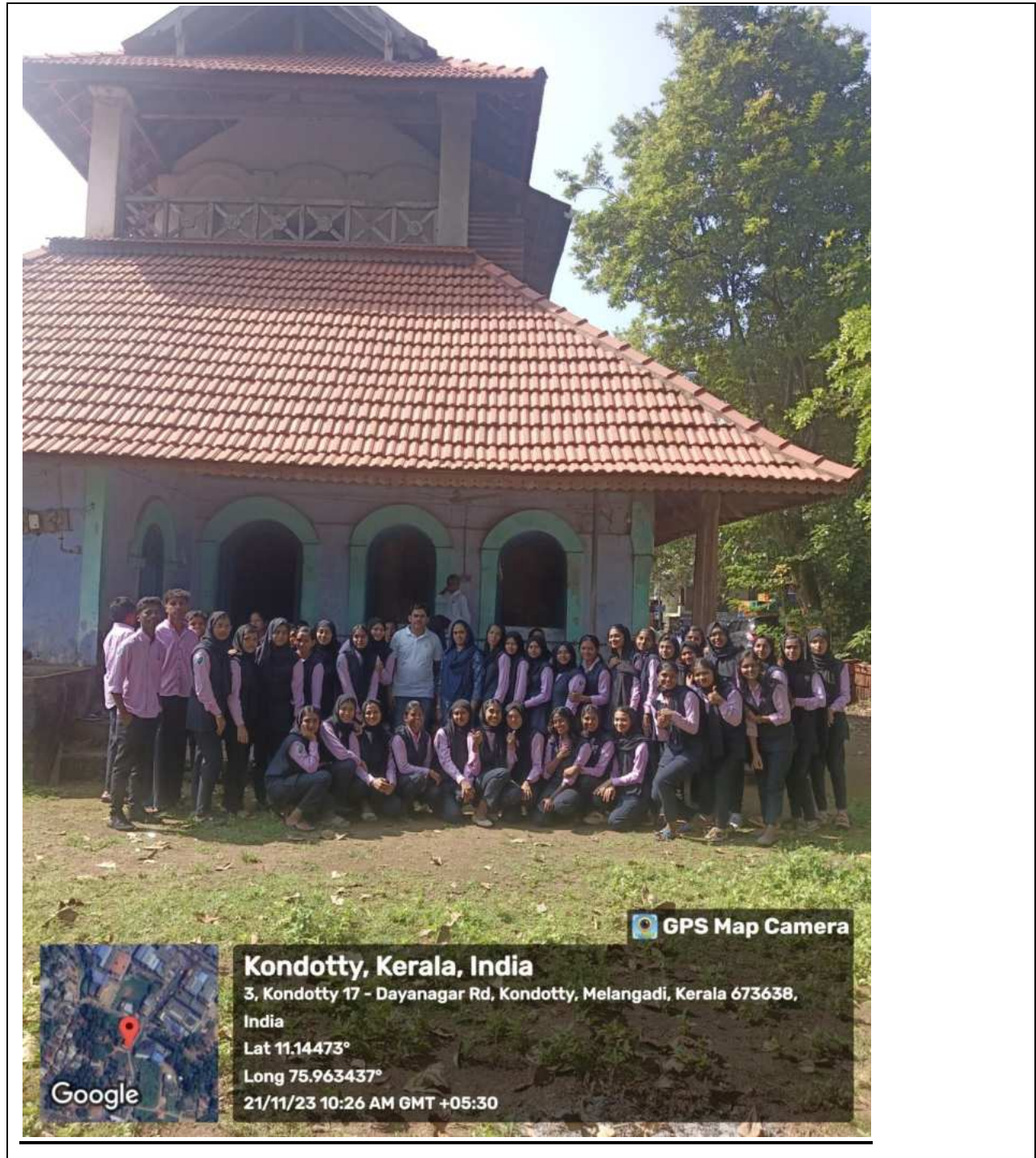
The heritage walk and study indeed proved to be a great learning experience for the students. The visit has exposed them to the need to understand and preserve the heritage structures in our locality.

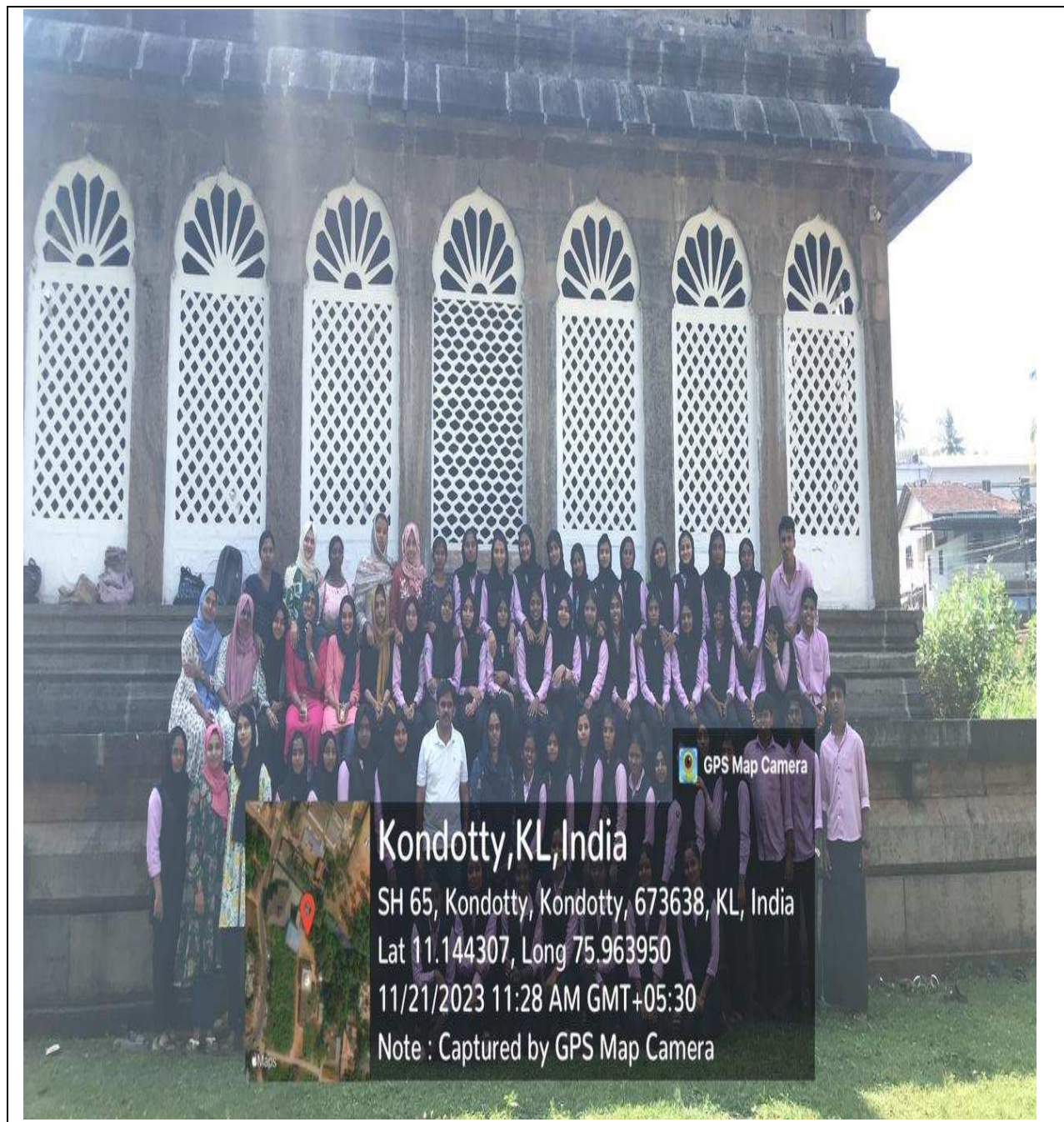
